\_\_\_\_ Applied online for tuition assistance with FACTS Tuition Aid (if applicable) at <https://online.factsmgt.com/signin/3MC25>. Tuition assessments will be conducted by FACTS. Once your assessment is completed, you will be informed of your tuition charges. Applications should be submitted by **Monday, June 1, 2015**. A \$100 late processing fee will be charged for applications received after **June 29, 2015**.

\_\_\_\_ Included immunization and health records for **all new entrants, Nursery, Pre-K, Kindergarten, Grades 2, 4, and 7. Grade 6** require a record of TDAP vaccine and **Day-Care** age children must include Medical Clearance for Day-Care.

\_\_\_\_ Included registration fee: \$125 per student, limited to a maximum of four registrations per family. Early bird cos is \$100 per student if complete applications are submitted by **Monday, June 1, 2015**. Checks should be made out to Ohr Temimim School.

\_\_\_\_ Reviewed fundraising schedule. These payments will be made through FACTS. Please refer to the details in the *Tuition* sheet enclosed.

\_\_\_\_ Completed Building Fund pledge. \_\_\_\_ Have not pledged yet. Enclosed is our pledge form.

\_\_\_\_ Applied/re-certified for The Bison Scholarship Fund, if applicable. Eligible families who do not apply in a timely manner will automatically pay \$500 over their assessed tuition per child.

\_\_\_\_ Completed E-rate funding survey. All parents are required to complete this survey in order for school to receive subsidies (2 pages).

\_\_\_\_ Applied for Day-Care subsidies (ages 3-5). Working parents with limited income are eligible for subsidies. These subsidies are applied to full tuition. Parents applying for subsidies may call the NYS Office of Family Services at [716.858.8953](tel:716.858.8953) and follow the prompts to request an application. Please contact the school office for assistance with this application. Please be reminded that tuition adjustments are considered only after applying to all available grants and subsidies.

\_\_\_\_\_ I understand that scholarships will be considered once:

1. Registration is complete (including health records, FACTS Tuition Management enrollment and Registration fees).
2. Scholarship application is received by FACTS Tuition Grants and Aid.
3. I have applied/complied with all available grants in our community when applicable (Bison Scholarship Fund, NYS Office of Family Services, etc.).
4. I understand that subsidies and scholarship funds are applied towards the full tuition of the grantee (and not applied to reduced rates).

### **Health Appraisal Information**

- ❖ If your child will be having an appointment for a physical during the months of May-August, please make note of the appointment date on the registration form. Early Bird registration will still apply if health and immunization forms are handed in within 3 days of the appointment.
- ❖ **Please contact the school office if:**
  - a) You are unsure whether your child needs a health appraisal.
  - b) You recently handed in your records and wish to know if you need to hand in more information.

## **OHR TEMIMIM TUITION FEES AND SCHEDULE FOR 2015-2016**

### **TUITION CHARGES PER CHILD:**

Day-Care children ages 3-5 Mon.-Fri. 8:30am-2:30pm \$10,680  
 (*Children born before December 1, 2012*)  
 \$3,680 scholarship available for those who qualify

Extended Care is available for Nursery, Pre-K and Kindergarten children for \$10 daily or \$1,440 for the year. Please contact school to make reservations.

Grades 1-8 Mon.-Thurs. 8:30am-4:00pm, Fri. till 2:30pm \$9,000.00

Tuition payments will be processed through FACTS Tuition Management. Changes to your payment schedule will be charged a \$15 processing fee. There is no fee for the first request.

Tuition assessments will be conducted by FACTS Tuition Grant and Aid. Once your assessment is completed, you will be informed of your tuition charges. Please apply online at <https://online.factsmgt.com/signin/3MC25>. Applications should be submitted by **Monday, June 1, 2015**. A \$100 late processing fee will be charged for applications received after **June 29, 2015**.

The Bison Children's Scholarship Fund awards are mailed directly to the school. Parents will be required to stop in two times over the year and sign paperwork as needed. For more information, please visit [www.bisonfund.com](http://www.bisonfund.com). Parents requesting a scholarship must apply. Ohr Temimim will announce via e-mail once registration is made available.

### **REGISTRATION FEE:**

A non-refundable \$125.00 registration fee per child is to accompany each application, limited to a maximum of four registrations per family. *Early Bird registrations:* Apply by **Monday, June 1, 2015** and pay \$100 registration fee per student. Early bird is awarded to **complete** registrations only.

### **VOLUNTEER TIME:**

For each \$1,000.00 in tuition assistance, 15 hours of volunteer help is required. Please inform the school office how you can help.

### **FUNDRAISERS:**

Participation in five annual fundraisers is required of all families with children in any school program. These amounts will be withdrawn through your FACTS Tuition Management account. Any checks turned in from other parties towards fundraisers will be credited to your tuition account.

1. Purchase or sell \$50 worth of Rosh Hashanah school cards.
2. Raise \$250 towards ads in the *Parness Hayom* Calendar. Due to the time and cost of this project, the school will be acknowledging 75% of funds raised through *Parness Hayom* to cover for other fundraisers and/or tuition.
3. Purchase or sell \$200 worth of Adar Daily Drawing raffle tickets.
4. Purchase or sell SCRIP gift cards totaling the amount of \$2,000 over the school year or a payment of \$200 will be charged to your FACTS account by June 2016. This is a way of helping the school with no additional cost to you. If less than \$2,000 is spent, the charge will be prorated.
5. Complete payments/pledge for the Capital Fund Campaign.
